产品特点

该冰吧是单门风冷无霜冷藏箱，上部为酒区，可放置葡萄酒、起泡酒等饮品，中部间室为冷藏室，可放置瓜果、蔬菜、蛋类、奶类等需要进行冷藏保鲜的食品，底部变温室可根据需要设置合适温度，存放需冷藏保鲜的食品或存放鱼类、肉类等需冻结存放的食品。

★全电脑温控

- 冷藏室、葡萄酒储藏室和变温室由电脑温控系统分别控制；
- 温度设定简单方便；
- 忘关门提醒功能；

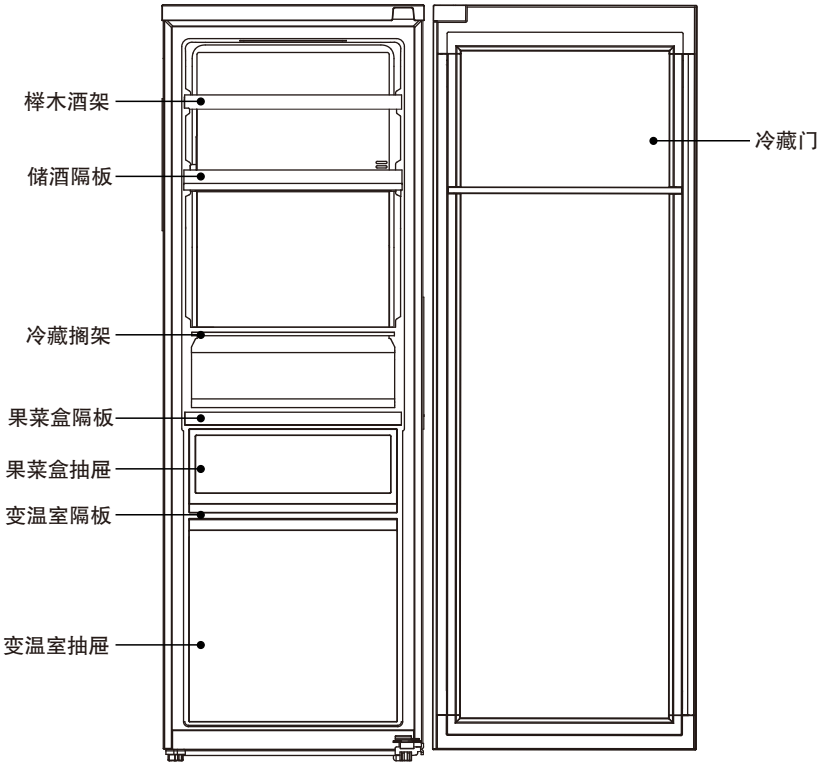
★风冷无霜技术

冰吧制冷风道采用立体多层出风，保证储藏温度的均匀性。冰吧可根据实际使用频次、结霜的快慢进行智能化霜。化霜前自动判断冰吧内的温度，并进行预制冷，使化霜前后箱内温度没有较大幅度的改变，利于食品的保鲜。

★更多人性化设计

冰吧采用宽电压带设计，具有自动稳定控温、断电记忆、开机延时、自动报警等功能。

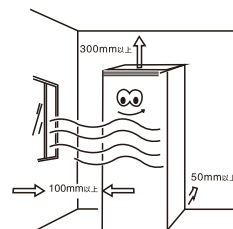
拆除全部外包装组件,包括泡沫底座及固定附件所用的胶带也必须拆除。清点随机附件和资料,请按照产品装箱单核对附件,如有出入,请及时与销售商联系。



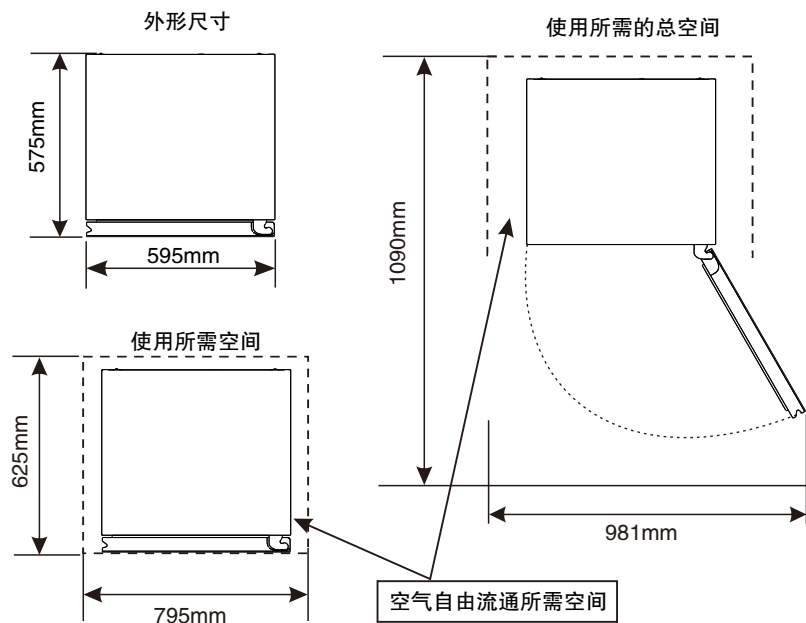

★放置环境

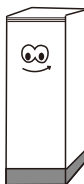
- (1)热气少,通风条件好的地方。避开炉子旁边和阳光直射的地方,以免降低制冷效果,同时也为了省电。
- (2)潮气少的地方,以防止冰吧生锈和漏电。
- (3)安装冰吧的房间总空间除以本冰吧制冷剂的灌注量不得小于1m³(空间)/8克(制冷剂)。
注:冰吧制冷剂的灌注量可在冰吧的铭牌上找到。
- (4)留出散热空间。冰吧为了冷却食品,在工作时向周围散发热量。冰吧上部应留有300mm以上的间隙,两侧应留有100mm以上的间隙,背面应留有50mm以上的间隙。

(5)地面要平稳。选择地面（地板）结实平整处，旋转调节脚，使冰吧保持平稳。安放不平衡，会引发振动和噪音；在地毯、草垫、聚氯乙烯地面材料上放置时，请在冰吧下面铺垫结实的垫板，为防止因冰吧散热而使地毯变色。



警告

器具周围或在嵌入式结构里无障碍物，保持通风通畅。

使用准备

★开始使用

(1)静置

冰吧安放调平、清洁完毕后，先不要接通电源，让冰吧静置1小时以上，再接通电源，以确保冰吧的正常运转。

(2)清扫冰吧内部

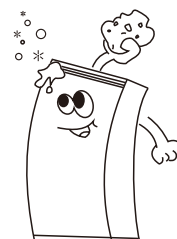
确认附属部件，用柔软的布擦拭冰吧内部。

(3)接通电源

将插头插到牢固的专用插座上，压缩机启动运行。1小时后，打开变温室门，变室内温度明显下降，表明制冷系统工作正常。

(4)冰吧充分变冷后把食品放进去

冰吧运行一段时间后，将按用户设定温度状况自动控制冰吧内温度。待冰吧充分冷却后，放入食品，通常需要经2~3小时食品可充分冷却；夏季因温度较高，食品充分冷却需4小时以上(冰吧内部变冷之前应尽量减少冰吧开门次数)。



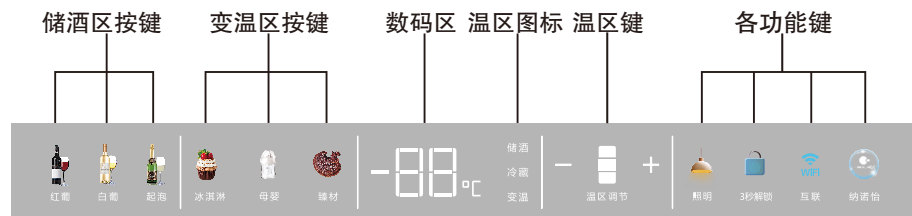
注意

漏电断路器的设置：若冰吧安装在水气多的地方，必须检查并保证地线和漏电断路器的正常。冰吧碰到墙壁发出振动声音的时候，或者墙壁因为压缩机周边空气对流的影响而变黑的时候，把冰吧从墙壁处离开。冰吧的设置可能会引起周围的移动电话、固定电话、收音机、电视机出现杂音，影像混乱等情况。这时候，要把冰吧尽量移开。

★关于无氟冰吧

冰吧使用了无氟制冷剂(R600a)以及无氟发泡隔热材料(环戊烷)，不破坏臭氧层，对地球温室化带来的影响非常小，是环保材料。

功能设定

★ 初次上电

冰吧初次连接电源，显示屏全亮显示5秒后恢复正常显示，首次上电时储酒室默认设置为红葡模式，变温室默认为冰淇淋模式，照明灯默认为蓝光模式，纳诺怡模式设置为开。

各按键操作：

★温区键：选择调节冰吧储酒、冷藏、变温温区，每次按下温区调节按键，当前温区图标熄灭，下一温区图标点亮，同时数码区域显示当前温区设定温度。

★-键 和 +键为温度调节键：调节各温区的温度，数码图标闪烁显示，每按一次按键，LED显示温度变化1℃，停止操作5秒后调节生效，退出调节界面，同时数码停止闪烁。

注：如果当前温区设置了相关功能，则温度调节操作无效。

各间室温度设定范围与温度调节：

葡萄酒储藏室：5℃ ~ 18℃；

冷藏室：2℃ ~ 8℃；

变温室：5℃ ~ -20℃。

白葡指示灯高亮显示时表示储酒室设为白葡模式；白葡模式下短按白葡键退出白葡模式；

白葡指示灯半亮显示时可通过短按白葡键储酒室进入白葡模式，同时退出红葡模式、起泡模式；

★起泡键：进入/退出起泡模式。

起泡指示灯高亮显示时表示储酒室设为起泡模式；起泡模式下短按起泡键退出起泡模式；

起泡指示灯半亮显示时可通过短按起泡键储酒室进入起泡模式，同时退出红葡模式、白葡模式；

★冰淇淋键：进入/退出冰淇淋模式。

冰淇淋指示灯高亮显示时表示变温室设为冰淇淋模式；冰淇淋模式下短按冰淇淋键退出冰淇淋模式；

冰淇淋指示灯半亮显示时可通过短按冰淇淋键变温室进入冰淇淋模式，同时退出母婴模式、臻材模式；

★母婴键：进入/退出母婴模式。

母婴指示灯高亮显示时表示变温室设为母婴模式；母婴模式下短按母婴键退出母婴模式；

母婴指示灯半亮显示时可通过短按母婴键变温室进入母婴模式，同时退出冰淇淋模式、臻材模式；

★臻材键：进入/退出臻材模式。

臻材指示灯高亮显示时表示变温室设为臻材模式；臻材模式下短按臻材键退出臻材模式；

臻材指示灯半亮显示时可通过短按臻材键变温室进入臻材模式，同时退出冰淇淋模式、母婴模式；

功能介绍

★照明键：短按照明键，白光和蓝光两种模式选择切换；长按照明键3秒进入照明灯延长熄灭模式直到冰吧断电；

★互联网键

互联指示灯高亮显示时表示冰吧已连接路由成功；解锁状态下，长按3秒“互联”图标解除绑定。

互联指示灯半亮显示时通过以下方式绑定：

解锁状态下，长按3秒“互联”图标进入蓝牙绑定模式；

锁定状态下，长按3秒“照明”+“互联”图标进入softAP绑定模式；

★纳诺怡键

纳诺怡指示灯高亮显示时表示设为纳诺怡模式；纳诺怡模式下短按纳诺怡键退出纳诺怡模式；

纳诺怡指示灯半亮显示时可通过短按纳诺怡键进入纳诺怡模式。

★3秒解锁键：显示板锁定状态下，长按该键3秒解锁显示板；

★开门报警

当冰吧门打开超过3分钟以上时，蜂鸣器会发出“嘟、嘟、嘟..”的报警音，关上冰吧门就可中止报警；或者按任一键也可以中止报警，但3分钟后报警声会再次响起。

★故障报警

当冰吧操作屏显示“E0”、“E1”、“E2”、“EH”、“EC”时，说明冰吧发生故障，请尽快联系售后人员上门服务。

对手机、无线路由器的要求

安卓智能手机（8.1版本以上），建议使用手机分辨率为1280*720以上，如果您的手机分辨率低于此范围，可能造成手机界面的显示异常。苹果手机建议使用iOS9.0以上系统。准备一台无线路由器（符合IEEE 802.11b/g/n协议），并且记住无线路由器的名称和无线网络密码。智能冰吧支持2.4 GHz（IEEE 802.11b/g/n协议）WiFi网络。

6. 通过手机客户端可以实现远程控制、食品在库管理、食谱搜索等功能，为了更好的操作体验请及时更新手机客户端软件。

手机注册、登录

打开 APP，进入注册登录页面，使用手机号进行新用户注册，提示注册成功后，重新登录。

请注意：

第一次使用客户端时需要注册，注册成功后，后续使用客户端时只需要输入用户名和密码即可登录。

功能介绍

手机与冰吧绑定

登录 APP 后，按页面提示绑定您的冰吧。选择“手动查找”，手动选择您购买的机种进行绑定，根据 APP 页面提示进行绑定设置。

冰吧端 WiFi 设置：

冰吧门打开后，解锁并长按互联按键 3 秒后，温度设定区显示 L0，然后按照 APP 页面提示进行设置，完成手机与冰吧的绑定。

请注意：

- 手机与冰吧绑定时，请确保手机与冰吧连接到同一网络，否则将无法成功绑定。
- 长按 APP 主页面已绑定的冰吧可进行解绑或重命名。
- 冰吧端解绑已绑定的冰吧：

冰吧门打开后，解锁并长按互联按键 3 秒后，冰吧断开路由器，WiFi 功能图标熄灭。

- 当您的冰吧进行废弃或转让时，请确保已重置路由器信息并清除所有绑定用户。
- 维修过程中冰吧的信息可能会被初始化，维修完毕后请重新绑定。
- 路由器名称或密码更改后，请重新绑定。

APP 远程操作

冰吧绑定成功后，可使用 APP 对冰吧进行远程操作，对冰吧的温度、功能等进行设定。

请注意：

- 冰吧解锁后，无法使用 APP 操作菜单，会出现“本体操作中”的提醒。
- 冰吧断开网络时，无法使用 APP 操作菜单，会出现“本体离线”的提醒。

小程序的使用方法

松下智能 APP 绑定冰吧后，通过 APP 可以进入微信小程序，也可以分享微信小程序给他人。通过小程序，您可查看冰吧信息、远程控制冰吧（限部分功能）、查看菜谱。另外，您还可以在小程序查看报修方式、进入购物商城等。

请注意：

使用小程序控制冰吧时，请仔细确认冰吧运行状态，避免误操作导致冰吧内存放的食物变质。根据手机客户端的更新，功能会有所调整，具体以客户端实际界面为准。

食物储藏

食物储藏位置

由于冰吧内的冷气循环，使冰吧内各区域的温度存在差异，所以不同种类的食物应放在不同的区域。

★冷藏室宜于储存不需冻结的食品，烹调好的食品、啤酒、鸡蛋、需要冷藏的零星调料，牛奶、果汁等；果菜盒宜于保存蔬菜、水果等。

★酒区是用来储存白葡萄酒、红葡萄酒、起泡酒和其他需要冷藏的饮品的功能区域。

冷藏室的使用

★冷藏室大部分区域的温度平均在 2°C ~ 8°C 间，短期贮藏或随时要吃的食品请放在冷藏室。

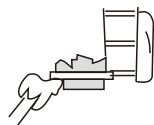
★果菜盒：果菜盒向外拉，存取食品。果菜盒盖板在使用时或清洁后必须放在果菜盒上面，以免影响果菜盒内温度。

冷藏食品注意事项

★洁净食品：食品最好先清洁、擦干，再放入冰吧内贮藏；食品放入冰吧之前，最好先密封起来。一是可以防止水分蒸发，保持水果、蔬菜新鲜；二是可以防止食品互相串味。

★冰吧内的食品不要过多、过重：食物之间要保留足够的间隙，如果太近，冷空气流通受阻，会影响制冷效果；食品不要存放过多、过重，以免搁架被压坏；放食品时注意稍离开内壁一些；含水份较多的食品也勿太靠近冷藏室后壁，以免冻结在冷藏室后壁上。

★食品要分类冷藏：根据食品种类分开存放，每天吃的食物最好放在搁架的前面，既可避免长时间开门，也不会因忘记而发生食品过保质、保鲜期的现象。



食物储藏

★果蔬的存放：

- (1)水果、蔬菜应放入果菜盒中以保持水份与新鲜度；
- (2)蔬菜应逆着生长方向存放，这样可以有效地延长蔬菜的保鲜期；
- (3)萝卜类应切掉叶子，防止营养被叶子吸收；
- (4)西红柿要待成熟后放入，若将未成熟的西红柿直接放入，鲜度会下降；
- (5)香蕉、菠萝、甜瓜、菱瓜、木瓜等热带水果不宜存放，这些食品在低温下新陈代谢会加快，有时会变质。不过短时冷却一下也无妨；
- (6)南瓜、土豆、白薯、大蒜、生姜、洋葱等根茎类食品是不需要冷藏的。

变温室的使用

本冰吧特设变温室，温度可以在（ 5°C ~ -20°C ）范围之间调节。

- ★当温度设置在 2°C ~ 5°C 时，可以做为冷藏室使用。
- ★当温度设置在不同的档位时，建议储存相应的食品。
- ★食品堆放不要集中放置，可分成若干份放置，以免影响制冷效果。

软冻妙用

- ★冰吧变温室温度设置在 -7°C ~ -3°C 时可实现软冷冻，具有以下优点：
 - (1)零解冻时间：食用前无需人工或微波解冻，降低用电量，方便生活。
 - (2)锁住营养保新鲜：没有通常解冻后的残留血水，减少营养成分流失。
 - (3)切取容易：可以切薄片，可以细切，切后容易保持形状而不碎。
 - (4)重叠冻结的可简单的分开，冻结后仍为一体，任意取出食用部分即可。



为了更好地存储食品，请您根据间室设定的温度存放相应的食品，以免造成不必要的损失。

食物储藏小常识

不需要冷却的食物不要放入

★不适合冷冻的食品举例：

生鸡蛋、白煮蛋：生鸡蛋的蛋壳会破裂，煮蛋的蛋白会变硬；生的菜叶类，生的薯类、乳制品、沙拉酱、蔬菜、豆腐等。

★不适合冷藏的食品举例：

香蕉、甜瓜、菠萝、木瓜、凤梨等热带水果：因为温度低，水果的成熟速度变慢，时间长了可能变质。当然，吃之前冰一下是可以的。

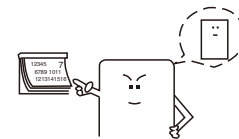

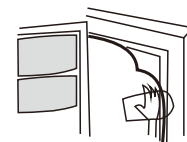

冰吧工作时的非故障现象

★运行时的声响：冰吧在工作时，由于温度的变化，蒸发器和管路会由于热胀冷缩发出“啪啪”的声音。主控板、继电器、热保护器等电气件会由于动作而发出“咔嚓”声，制冷剂在管道中流动时，能听到“滋滋”流水声。

★冰吧表面有水珠：在多雨潮湿的季节或环境湿度较高时，冰吧外侧或门封条处可能出现少量的水珠，用软布擦干即可。

★压缩机发热甚至有烫手的感觉：这是冰吧工作时压缩机运转所引起的，压缩机外壳温度最高可达90℃左右，应避免接触。

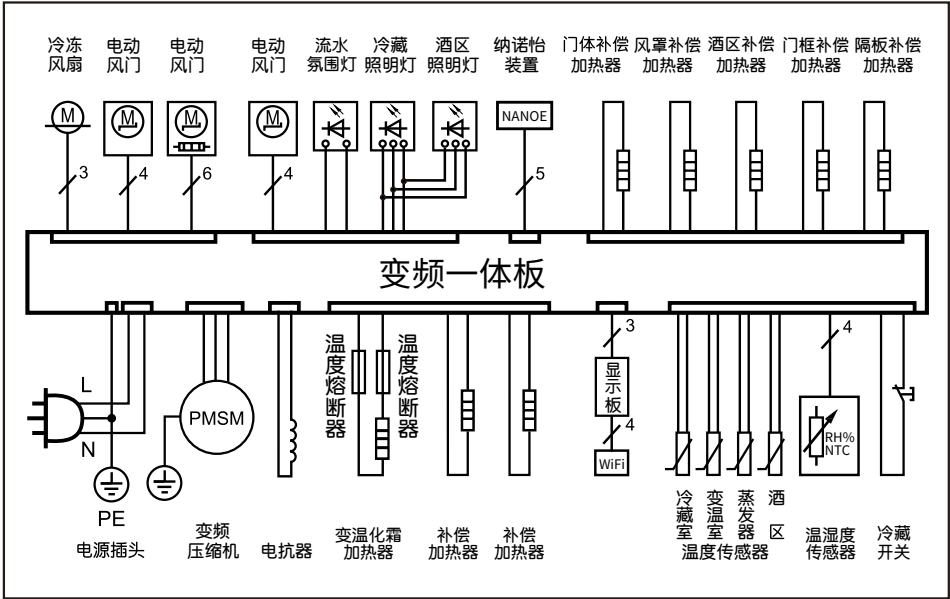
